- New Cars Indent.** For indent of any new cars, a \$2,000/\$3,000 deposit is required. To be refunded at end of rental contract.
- Terms of Payment.** Rental to be paid Up-front at the start of the Week. To pay to **DBS Current Account 002-002405-5**. Please state under Remarks your "IC, Name".
- Late Payment Interest.** A flat charge of \$60 (GST incl) will be levied if the hirer fails to pay their weekly hiring fees by every Thursday, 2359hrs. Penalties must be paid by the following week.
- Rates Inclusive.** Road Tax, Maintenance and Insurance.
- Replacement Vehicle.** Replacement of vehicle will NOT be of same age. Downtime can be due to servicing or minor repairs. C&P reserves its right to give replacement or rebate.
- Driver Prerequisite.** Singaporean, Age : 23-65yo, License : Min 2yrs Experience
- Driver Documents Required.** Driver's IC & License, Limo Company with Code 49219 and a recent PP Photo.
- Car Hire Documents Provided.** Rental Agreement, Vehicle Log Card and Insurance Cert.
- Ride Hiring Companies.** C&P is not responsible for any change in hiring policies of Uber and Grab. If there are any changes of policy at the ride hiring companies, the hirer is still expected to fulfil his lease contract period.
